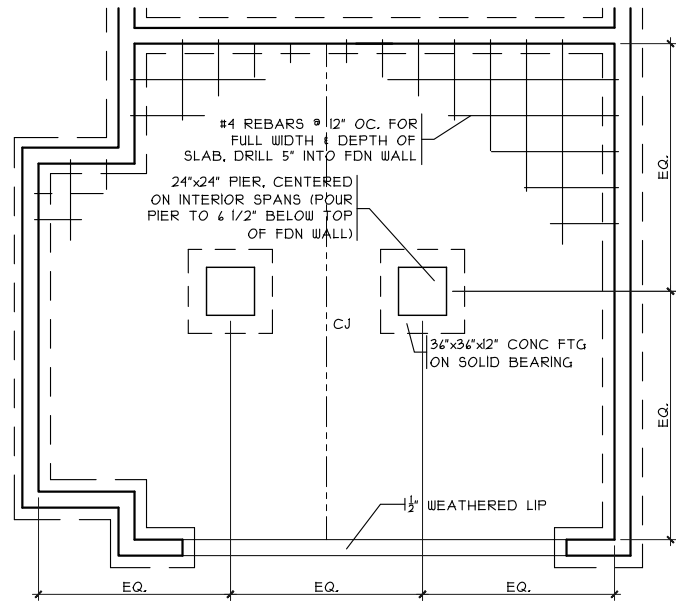

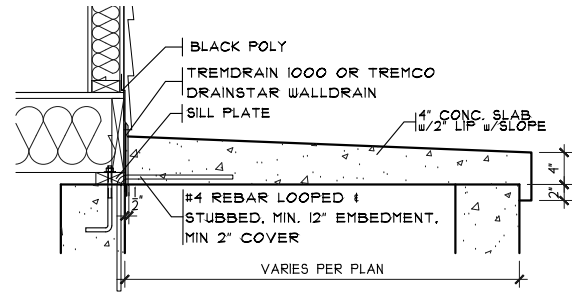

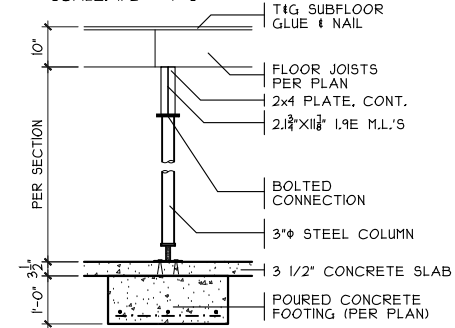
GRADE BM DETAIL

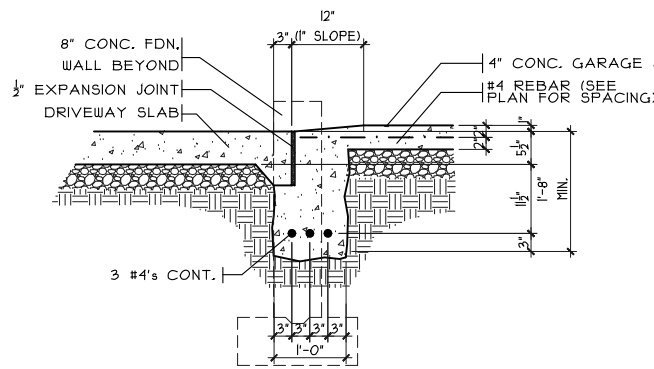
PORCH DETAIL

COLUMN DETAIL

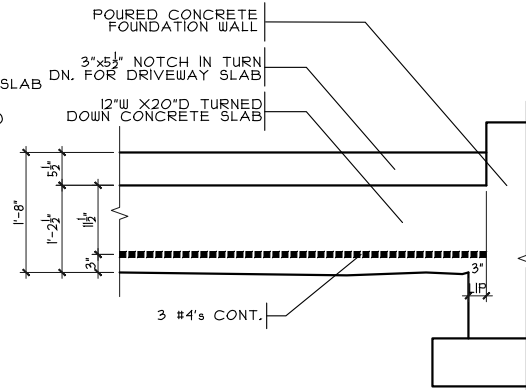

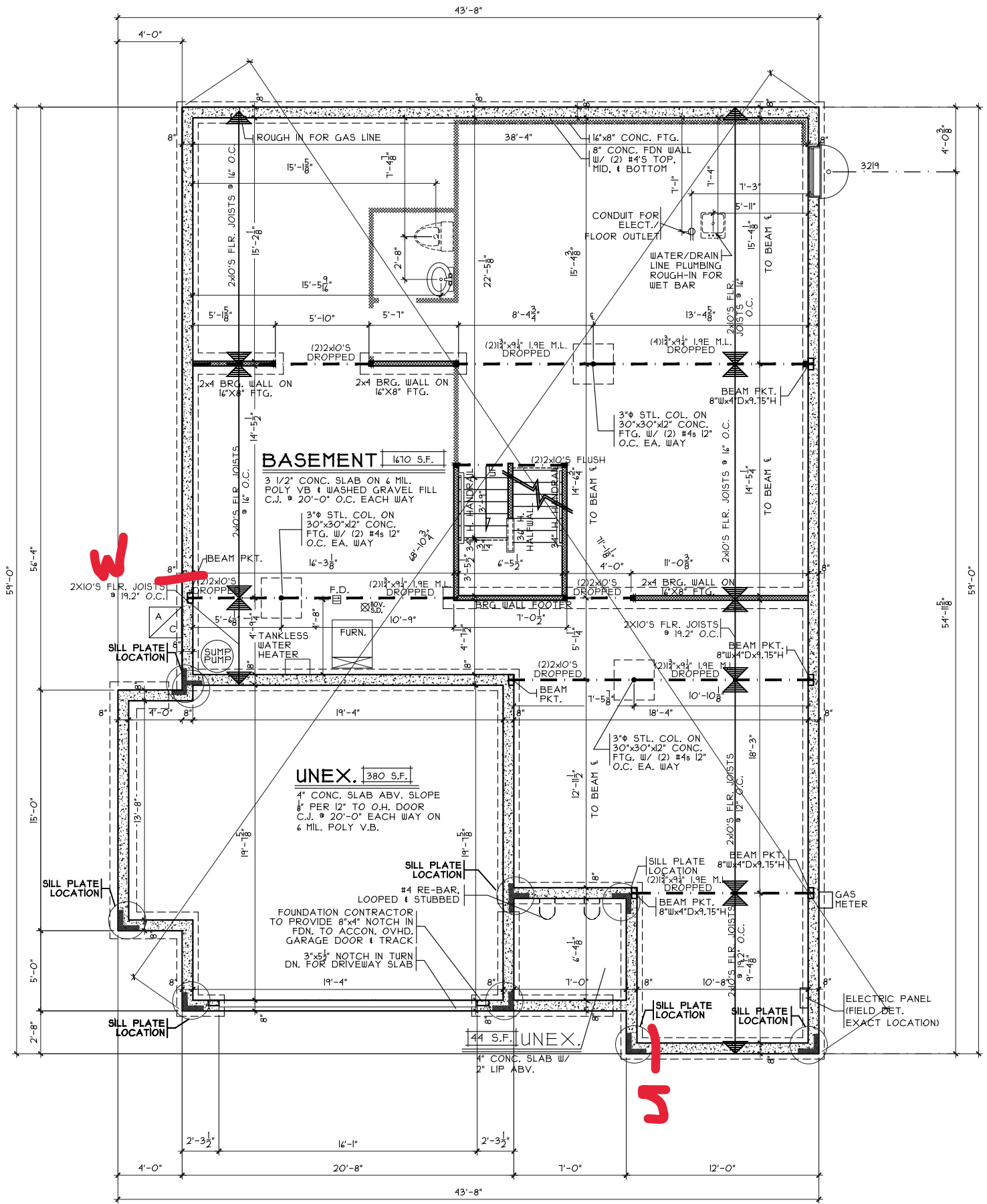

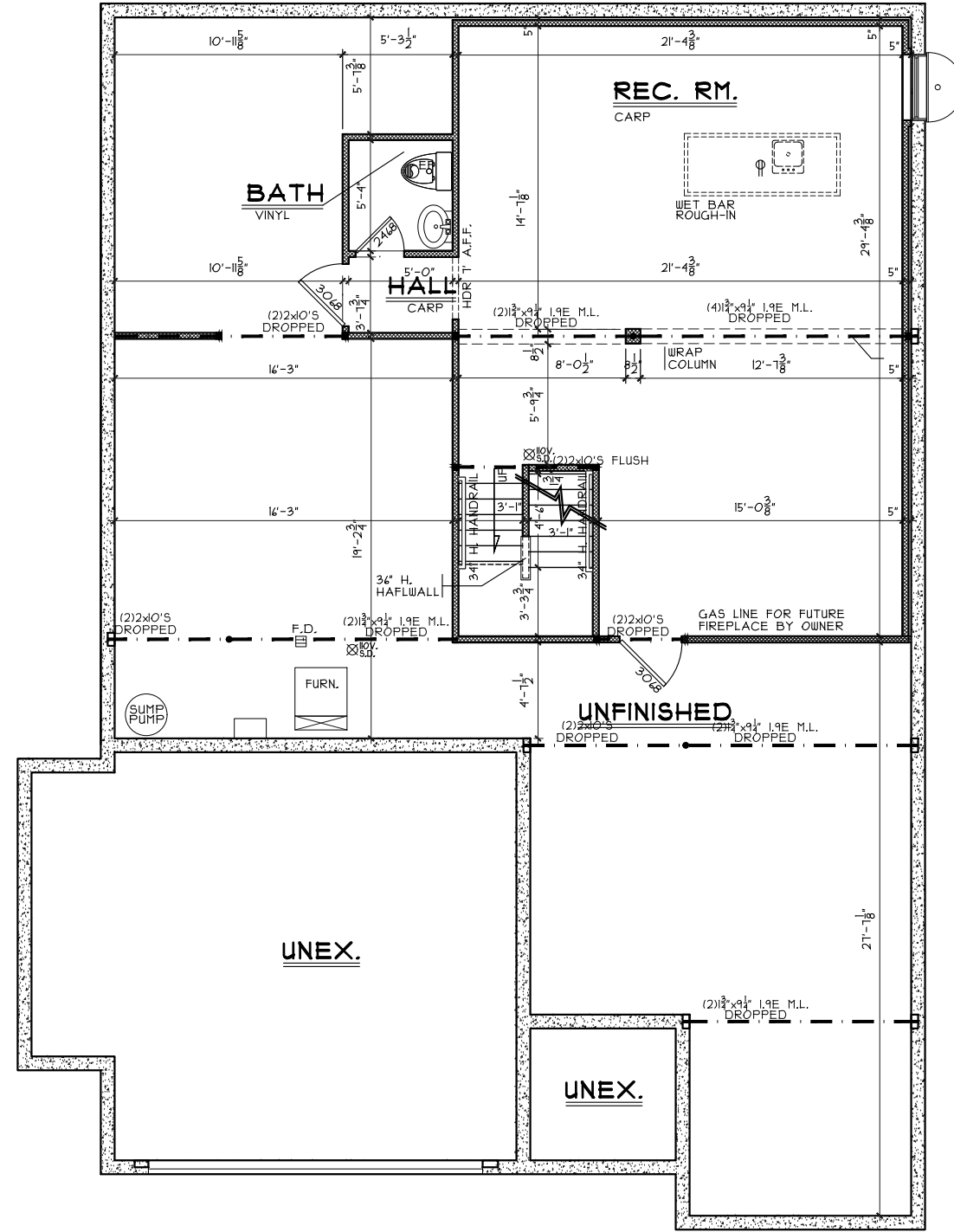
